April 6, 2020 Mayville City Council

The Mayville City Council met in regular session on April 6, 2020 at 6:00 pm in the council chambers with Mayor Bensen presiding and the following Aldermen responding in person to call of the roll: Carr, O'Brien. The following Aldermen responding to call of the roll by conference phone call: Bohnsack, Meshefski-Labine, Moen. Absent: Petersen. Also, in attendance: Gail Olstad, Julie Christianson, Cassie Tostenson, Shelia Anderson, Brandon Reber, Jack Hoss.

O'Brien made a motion to accept the approval agenda on the following items:

- 1. Minutes from 03-02-20 meeting.
- 2. Minutes from 03-19-20 (COVID-19 Emergency Declaration)
- 3. Auditor's office approvals: Stub's Bar transfer liquor license to Mayville for Firemen's Fundraiser raffle, 03-14-20 until 02:00 am 3-15-20. Mayville State University Foundation to conduct raffle ending April 25, 2020.
- 4. Conferences & Training Opportunities: NDIRF Annual Convention, May 20, Bismarck ND.
- Clean Up Days: Landfill open, free of charge to Mayville residents, Saturday, May 9 through Saturday, May 16 (excluding Sundays). Materials need to be sorted. No curbside pickup this year. See calendars for days, dates and times.

Carr made the motion to approve the bills as presented as March actual & April estimated. O'Brien seconded the motion, motion carried

Financial reports were given through December 2019. Moen made a motion to accept these financial reports. Meshefski-Labine seconded the motion, motion carried.

Carr made the motion to accept April & May 2020 calendars. Please note that Offices will be closed for Good Friday, April 10th; Tax Equalization Meeting on April 30 at 5 pm for which we need a quorum. Office closed, Memorial Day, Monday, May 25. O'Brien seconded the motion, motion carried.

Jack Hoss – VPP – Owners of the Trailer Court Apartments and Trailer Park. Jack informed the Council that there are 30 apartments in total with 17 of them being currently occupied. The trailer park has capacity for 36 trailers but currently has only 12 trailers. It was decided to have the auditor look at the bills and rates to see if there is anything that can be done to help with utilities.

Brandon Reber from Moore Engineering is going to be putting the City of Mayville on the SWC list for the 2021-2023 biennium. The SWC has some funding opportunities for up to 60% grant funding. The deadline for filing is the end of April 2020. Bohnsack made the motion to have Moore Engineering sign the city up. Moen seconded the motion, motion carried.

The City of Mayville made a request to consider increasing their policy liability coverage. Our current coverage is at \$1 Million. Hub International provided us with additional coverage increments. Carr made the motion to accept to increase to another 2 million liability coverage at an additional cost of \$1140.00. Bohnsack seconded the motion and upon a roll call the following voted: Yea: Meshefski-Labine, Moen, Carr, Bohnsack, O'Brien; Nay: 0; Absent: Petersen.

O'Brien made the motion to approve a sale of cemetery plots to Robert & Lenora Gayle Brown in Section 4A NH, Lot 10, Graves 03 & 04. Bohnsack seconded the motion and upon a roll call the following voted: Yea: Moen, Carr, Bohnsack, O'Brien, Meshefski-Labine; Nay: 0; Absent: Petersen.

Discussion was held about allowing Comet Athletic Club to provide gaming at the Top Hat Lounge, Stub's Bar and Tommy's Sport Bar, July 1, 2020 – June 30, 2021. Moen made the motion to accept this offer. Meshefski-Labine seconded the motion, motion carried.

O'Brien made the motion to allow the City Auditor to publish notice of Clean Up Days in the newspaper. Bohnsack seconded the motion, motion carried. The question was asked whether to impose a fine if materials hauled to the landfill were not properly sorted but was tabled at this time.

O'Brien made the motion to accept the resolution to adopt a policy for property tax exemptions granted under North Dakota Century Code Chapter 57-02.2 related to tax exemptions for improvement to commercial and residential buildings as presented. Meshefski-Labine seconded the motion and upon a roll call the following voted: Yea: Moen, Carr, Bohnsack, O'Brien, Meshefski-Labine; Nay: 0; Absent: Petersen.

A motion was made by Moen on FFCRA (Families First Coronavirus Response Act) Sick Leave Policy. To assist employees affected by the COVID-19 outbreak with job-protected leave and emergency paid sick leave. Meshefski-Labine seconded the motion, motion carried.

Loretta Larson put in her resignation for cleaning at the Public Library. Carr made the motion to accept Larson's resignation and to approve a replacement by 6-1-20 with Margaret doing the cleaning herself until then. O'Brien seconded the motion, motion carried.

O'Brien made the motion to adjourn the meeting with Carr seconded the motion, motion carried.
