Meshefski-LaBine moved to pay the bills, a second by O'Brien supported the motion, motion carried.

The Auditor reported that the adjusting entries for 2014 are being completed. This will restate 2014 and allow us a solid beginning for 2015 as well as complete the outstanding reviews of 2014. Audits have been forwarded to the lending agencies that the city works with.

Calendars for January, February and March were reviewed and discussed.

The Council received a Thank You for the plant from the Tvedt family.

NDLC March Madness is in Bismarck March 8 & 9, 2016. The Auditor's Office has rooms available if anyone needs.

The Stop sign requested by Cota/Lande was reviewed with the Traill County Sheriff Department at the Physical Plant committee and it was decided to authorize the change from a yield sign to a stop sign, this has already been changed out.

The low bidder on the North Dakota state vehicle contract is Nelson Ford of Fergus Falls, MN. Deputy Steinhauser estimated that the cost of the new vehicle will be in the range of \$27 – 28 K less trade in value of old vehicle plus the cost of police equipment. Net cost will be some over \$30 K as an estimate. Request for Bids will be posted once we have the okay from the Sheriff Department.

The Armory floor was refinished over the Christmas/New Year's Holiday in 2015. The school took the lead to get his accomplished and the City custodial staff worked with them to do the annual cleaning. Carlson reported they did an excellent job! Thank You!

The National Guard has a new NCO in charge of the Mayville Armory, Sergeant Tanner Norton.

NDLC Mayor for a day competition is coming up, Mayville will be pleased to be included if one or more of the teachers at the school are interested in pursuing it.

Mayville uses the State reimbursement rates by Ordinance. New Rates for 2016 are as follows: Mileage Rate: .54; Breakfast: \$7.00; Lunch: \$10.50; Dinner: \$17.50; Lodging \$80.10.

A permit was granted for the ShopKo signage.

Spring Election 2016 will be June 14<sup>th</sup>, 2016. Candidates running for elected offices in the June election can pick up petition forms in the auditor's office or get them on line. Positions up for election are 3 Council Members – at large – 4 year term and 3 Park Board Members – 4 year term. Petitions of nomination must be turned into the Auditor's Office no later than 4pm 4/11/16.

Meshefski-LaBine made a motion for the Auditor to advertise for insurance bids that for Liability Insurance to be opened March 7<sup>th</sup> at 6pm. Bohnsack seconded the motion, motion carried.

The Auditor's Office approved two liquor license transfers for the Pit Stop in Clifford.

Bohnsack made a motion to approve the signing of the contract between The Library and Domier Construction for a total of \$111,864 inclusive of all options. O'Brien seconded the motion an upon a roll call vote the following voted: Yea: O'Brien, Bohnsack, Carlson, Meshefski-LaBine; Nay: 0; Absent: Jorgensen, Petersen.

O'Brien made a motion to accept the Physical Plant committee recommendation to award the 2016 crack sealing contract to Northwest Asphalt at their bid price of \$0.63 per foot for a total of \$20,000 from the 105 Sales Tax Fund for \$15,000 budgeted and the remaining dollars from the 2013 91k highway distribution in the 102 Street Fund. Bohnsack seconded the motion and upon a roll call vote the following voted: Yea: Carlson, Meshefski-LaBine, O'Brien, Bohnsack; Nay: 0; Absent: Petersen, Jorgenson.

Carlson made a motion to approve the Physical Plant Committee recommendation to award the 2016 manhole elevation adjustment contract to Key Contracting of West Fargo, 15 manholes at \$1,100 each to be paid out of the 602 Sewer Fund. Meshefski-LaBine seconded the motion and upon a roll call vote the following voted: Yea: Carlson, Meshefski-LaBine, O'Brien, Bohnsack; Nay: 0; Absent: Petersen, Jorgenson.

Meshefski-LaBine made a motion to issue the Mayor's commendation to the Mayport Community Club for excellent work in organizing Winterfest:

WHEREAS: The Mayport Community Club decided in 2015 to re-establish a late fall community celebration to be known as "Winterfest," AND

WHEREAS: Members of the Mayport Community Club worked hard to organize a series of events that were enjoyed and appreciated by a large number of people – people from the surrounding area as well as citizens of Mayville and Portland, AND

WHEREAS: These activities served well to inspire community spirit among us and reflect favorably on our community,

NOW THEREFORE BE IT RESOLVED: That the Mayville City Council commends the Mayport Community Club for a job well done and much appreciated. Carlson seconded it, motion carried.

O'Brien made a motion to designate the Goose River Bank and the First and Farmers Bank as City depositories of public funds. Carlson seconded the motion supporting it and upon a roll call vote the following voted: Yea: Meshefski-LaBine, O'Brien, Bohnsack, and Carlson; Nay: 0; Absent: Petersen, Jorgensen.

# AN ORDINANCE TO AMEND CHAPTER II, ARTICLE 2 OF THE REVISED ORDINANCES OF 1979 OF THE CITY OF MAYVILLE RELATING TO REGULAR MEETING TIMES.

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MAYVILLE, NORTH DAKOTA:

SECTION 1. Section 2-0201 of Article 2 of the Revised Ordinances of 1979 of the City of Mayville, North Dakota, is hereby amended and reenacted to read as follows:

### ARTICLE 2. GOVERNING BODY - CITY COUNCIL.

#### 2-0201. REGULAR MEETINGS.

The City Council shall meet regularly at the City Auditor's office every first (1st) Monday in accordance with Section 40-08-10 of the North Dakota Century Code, at the hour of 6:00 o'clock P.M. unless some other time or place shall be specifically fixed by the Council.

SECTION 2. Effective Date. This ordinance shall be in full force and effect from and after the date of its second reading and final passage.
