CITY OF PORTLAND COUNCIL MINUTES

Monday May 11, 2015

The Portland City Council met in regular session on Monday May 11, 2015 in the Memorial Hall Building. The meeting was called to order by Mayor Sven Mickels. Also present were Aldermen JoAnna Nielson, Ed Lenaburg, Heather Hutchins and Public Works Director Ben Basol. Absent was Alderman Josh Braaten.

Justin Hall from Moore Engineering discussed change order #3 for the 2014 Street Replacement project. Mr. Hall met with Knife River to discuss repairs to Jahr Avenue, Helen Avenue, Fargo Avenue and the areas in town with tire impressions left in the pavement. All repairs will be done prior to seal coat this spring: Jahr Avenue – no structural issues and appearance issues will be corrected with seal coat; Helen Avenue – edge milling and repaire will be done; tire impressions left on Bennett Avenue and 4th Avenue will be heated and repaired; crack in apron on Broadway Avenue will be epoxied and repaired; Fargo Avenue – low spots will be re-milled and filled.

Motion Hutchins, second Nielson to accept \$8280.00 bid from Tri-State Paving to do the crack/seal work on the city streets, on roll, all aye, motion carried. City to get bid from Tri-State Paving for crack/seal work on the bike path.

Discussion held regarding the depth of city sewer lines at Heskin Meadows. Plans reviewed and available to contractor as needed. Property owners with basements may need to consider ejector pumps to sewer lines.

Motion Nielson, second Lenaburg to pay \$8105.23 to Xcel Energy to provide utilities to Heskin Meadows, on roll, all aye, motion carried. Motion Lenaburg, second Hutchins to approve to vacate Helen Avenue between 7^{th} Street and 6^{th} Street, on roll, all aye, motion carried. Motion Hutchins, second Nielson to approve the satisfaction of mortgage for property at 819 7^{th} Street, all aye, motion carried.

Minutes for the April 13, 2015 regular meeting were presented. Motion Hutchins, second Nielson to approve meeting minutes, all aye, motion carried.

Mail reviewed. Letter from MayPort Community Club discussed requesting donations for Summerfest 2015. Alderman Nielson confirmed to the council that there would be activities in the Centennial Park during Summerfest 2015. Motion Hutchins, second Lenaburg to provide a \$500.00 donation to Summerfest 2015, on roll, Hutchins, aye; Lenaburg, aye; Nielson abstained as she is President of the MayPort Community Club that is coordinating Summerfest 2015, Mayor Mickels, aye; motion carried.

Motion Hutchins, second Lenaburg to confirm the appointment of Thomas R. Moe as the City of Portland Municipal Judge, all aye, motion carried.
