Department Head Reports: Police - Ed Lenaburg: no report. Streets - Jerod Basol: no report. Water - Heather Hutchins: Overdue bills discussed. Fifteen (15) accounts scheduled to be turned off on Monday August 15, 2016 for non-payment. Letter to be sent to overdue accounts stating that the balance of these accounts must be paid in full to prevent water from being shut off. A \$100 turn on fee must be paid before water service will be restored. Failure to pay the fee and turn water on without the city approval will result in theft of services charges being filed by the City of Portland through the Traill County Sheriff's office. All accounts for Traill County Housing to be mailed to Traill County Housing in Hillsboro with a copy of the bills sent to the Fargo office, and not to individual customers. Buildings/Grounds/Equipment - JoAnna Nielson: no report. Director of Public Works: Motion Hutchins, second Lenaburg to approve increase of \$25 per month for cell phone reimbursement for Public Works Director, on roll, Hutchins, Lenaburg, Nielson aye, Basol abstain, motion carried. Mower upgrade discussed and City of Portland will wait until spring of 2017 to possibly upgrade. Mayor Mickels will be unable to attend the annual League of Cities convention, any alderman interested is welcome to attend. Motion Hutchins, second Lenaburg to renew contract for two (2) years and increase rent by \$25.00 for space currently rented to Jeff's Electric, all aye, motion carried.
