Bohnsack moved to pay the bills as amended, a second by O'Brien supported the motion, motion carried.

The 2016 Audit was distributed and the Council asked that Brady Martz be scheduled at a future meeting to present and discuss. The Auditor will get this scheduled.

Calendars for October and November were reviewed and discussed. It was noted that the JP meeting will be held on 10/31 in Hillsboro. We will hold a special meeting to review the final budget 10/09/17. Admin Committee will begin to be held on the 3^{rd} Monday each month, adding as of November 20^{th} , 2017.

The Auditor's office approved:

Liquor license transfer for Tommy's Sports Bar to Armory for Torgeson/Ness wedding. Bingo permit for Mayville Golf Club

Mayor Moen reported from the Annual League of Cities convention. Mayville will be a rep for 6 small cities in the area on the LAWA/RRVWSP Replacing Carol S. from Hunter.

Reminder was discussed on any curb side picking up after Oct 22nd will be charged \$250.00 for the city to clean up.

The Armory has officially been turned over to the cities, all keys have been turned into the Auditor's Office. Cal Peterson will be city's team member who will be the contact and main facilities person.

During the Sheriff Report Sheriff Hunt updated the Council that a new deputy, Jason Lee will be starting. Issues with unused vehicles and RV's being left on the streets was brought to Sheriff Hunt's attention.

Mike Gratton from the Mayport Coop and Travis Soderberg from Vigen Contracting presented to the Council how they would like to approach handling traffic while the silos are being slipped. After discussion Bensen made a motion to approve the temporary blocking of Main Street for 1 week during the slip, anticipated start time between Oct 20-27, the Coop will do ads, handouts and other communications to update the public. Bohnsack seconded the motion, motion carried.

Public 2018 budget hearing is scheduled to be held at October 9th at 6pm.

Meshefski-LaBine made a motion to accept the second reading of the following Ordinances (changes due to ND State Legislative 2017):

AN ORDINANCE TO AMEND CHAPTER X, ARTICLE 6 OF THE REVISED ORDINANCES OF 1979 OF THE CITY OF MAYVILLE BY AMENDING THERETO ORDINANCE NO. 10-0628.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MAYVILLE, NORTH DAKOTA:

<u>SECTION 1</u>. Ordinance No. 10-0628 is hereby amended to the Revised Ordinances of 1979 of the City of Mayville, North Dakota, to provide as follows:

10-0628 - SPECIAL PERMIT.

A licensee may apply to the City Council of the City of Mayville and the Attorney General for the State of North Dakota for a special alcoholic beverage permit to engage in the sale of alcoholic beverages at special events on such premises as may be designated by such permit. Such licensee shall be authorized to sell only alcoholic beverages authorized the licensee under Section 10-0605 of this ordinance.

The fee for such special alcoholic beverage permit shall be \$25 for each application and the duration of such permit shall not exceed a period greater than three consecutive days.

The City Council of the City of Mayville shall, in its discretion, authorize or deny, such application for a special alcoholic beverage permit based upon the rules and regulations contained within this ordinance and as amended.

The city may authorize persons under 21 years of age to be in the area of a special event if only beer, wine, and sparkling wine is being served and that is designated in the permit. The area where people under 21 are allowed must be designated on the permit and only employees of the alcoholic beverage licensee may serve alcohol. Further, people under 21 may not consume, possess, or receive alcoholic beverages.

<u>SECTION 2</u>. Effective Date. This ordinance shall be in full force and effect from and after the date of its second reading and final passage.

It was tabled at this time with the tight budget. Christian Gage who was hired by the city this summer will be available to work in Streets half time and we will have to hire as needed for snow removal is we have a bad year.

Meshefski-LaBine made a motion to adjourn, O'Brien seconded it, motion carried.
