Department Head Reports: Police – Jerod Basol: Dog complaints have been received. Resident to contact Traill County Sheriff's if continues. **Streets** – Craig Klabo: no additional report. **Water** – JoAnna Nielson: Overdue bills discussed. Nine (9) accounts scheduled to be turned off on Monday August 26, 2019 for non-payment. Letter to be sent to overdue accounts stating that the balance of these accounts must be **paid in full** to prevent water from being shut off. A \$100 turn on fee must be paid before water service will be restored. Failure to pay the fee and turn water on without the city approval will result in theft of services charges being filed by the City of Portland through the Traill County Sheriff's office. All accounts for Traill County Housing to be mailed to Traill County Housing in Hillsboro with a copy of the bills sent to the Fargo office, and not to individual customers. **Buildings/Grounds/Equipment** – Troy Grinde: no report. **Director of Public Works** - Ben Basol: Motion Nielson, second Grinde to approve \$640 to repair sidewalk outside of Jeff's Electric, on roll, all aye, motion carried.

Discussed the City of Portland accepting a quit deed for property from MayPort Farmers Co-op. Budget for 2020 reviewed. Motion Nielson, second Grinde to approve final 2020 budget, on roll, all aye, motion carried.
