Monday December 10, 2018

The Portland City Council met in regular session on Monday December 10, 2018 at 6:00 pm in the Memorial Hall Building. The meeting was called to order by Mayor Sven Mickels. Also present were Aldermen JoAnna Nielson, Jerod Basol, Craig Klabo, and Troy Grinde. Absent was Public Works Director Ben Basol.

Mickie Depaolis was in attendance to discuss additional insurance plans for city employees. A review of both short term disability and critical care plans was presented. Motion Grinde, second Klabo for the City of Portland to provide for both short term disability and critical care insurance for Public Works Director Ben Basol, on roll, all aye, motion carried. Motion Basol, second Grinde for the City of Portland to provide critical care and short term disability insurance for city auditor Nadine Rygg, on roll, all aye, motion carried.

Concerns were expressed regarding speeding on Ash, Oak and Madison Avenues in the City of Portland. Motion Basol, second Nielson for the City of Portland to add speed limit signage on Oak, Ash and Madison Avenue's to 25 MPH, all aye, motion carried.
