November 2, 2020 Mayville City Council

The Mayville City Council met in regular session on November 2, 2020 at 6:00 pm in the council chambers with Mayor Bensen presiding and the following Aldermen responding in person to call of the roll: Carr, Bohnsack, O'Brien, Gates, Moen, Petersen. Also, in attendance: Gail Olstad, Julie Christianson, Cassie Tostenson, Shelia Anderson, Brandon Reber, Brandon Oye, Cassie Braaten, Tymeka Cody.

O'Brien made a motion to accept the approval agenda on the following items:

- 3. NDDOT: Highway ND 200 chip-seal cost will be borne by state. No cost to the City of Mayville. FEMA permit submitted for approval and approved.

AN ORDINANCE TO AMEND THE REVISED ORDINANCES OF 1979 OF THE CITY OF MAYVILLE RELATING TO NON-CONFORMING USES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MAYVILLE, NORTH DAKOTA:

Section 1. That the ordinance related to non-conforming uses be amended read to as follows:

Non Conforming Uses.

If any nonconforming structure or any building in which there is a nonconforming use is damaged by fire, flood, explosion, wind, war or other catastrophe, in an amount equal to or greater than fifty percent (50%) of its assessed valuation, it shall not be again used or reconstructed to be used for any use except one complying with the provisions of this article for the district in which it is located.

Notwithstanding the foregoing provisions of this paragraph, any principal nonconforming use or structure that is damaged or destroyed by any means, to the extent of more than fifty percent (50%) of its structural value prior to the damage, that structure may be restored, repaired or rebuilt in its entirety if all of the following conditions are met:

- a) The building or structure will not occupy any portion of the lot that was not occupied by the destroyed structure;
- b) The building or structure will not have a greater floor area than the destroyed structure;
- c) The building or structure will not exceed the height or number of stories contained in the destroyed structure;
- d) The number of off-street parking spaces located on the property will not be reduced from the number available before the damage; and
- e) The building permit for the repair or restoration must be obtained within six (6) months of date of the damage and restoration must begin within one (1) year of the date of the damage.

Section 2. Effective Date. This ordinance shall be in full force and effect from and after the date of its second reading and final passage.

Carr made the motion to authorize the Auditor to notify current liquor license holders that renewal applications will be mailed and due back prior to December 7 Council Meeting. Moen seconded the motion and the motion carried.

Water Tower Mixer: Purchase with or without controls: Option #1 – GS-9 mixer without SCADA controls \$26,180; Option #2 – GS-9 mixer with SCADA controls \$30,828. The money would come from painting inside the water tower. Bohnsack made the motion to go with Option #2. Petersen seconded the motion and upon a roll call vote the following voted; Yea: Moen, Bohnsack, Gates, O'Brien, Petersen, Carr; Nay: 0.

CWSRF Project Information: Approve submission of questionnaire for projects needing financial assistance for construction in 2021 and later years. Wastewater treatment, interceptor sewer, collector sewer, stormwater and nonprofit (included landfill) projects are eligible. 1. A questionnaire must be completed for each new project not currently on the project priority list for which CWSRF assistance is desired. 2. Previously listed projects that do not yet have a CWSRF loan for which CWSRF assistance may still be desired. December 11. 2020 deadline for submission. Gates made the motion to accept to have Moore Engineering go ahead with this for the City of Mayville. Carr seconded the motion and the motion carried.

The Council decided to bring back next month the New Home Property Tax Exemption: County askes cities discussion on increasing the \$75K exemption more appropriate which has been on the book several years. Is \$150K more appropriate; and from county perspective easy to manage if all cities set similar exemption value. Discussion.

TCRMMMP – Ben Gates/Steve Hunt. Traill County Emergency Management Multi Hazard Mitigation Plan Update. Ben Gates cannot be this contact for the City. We need a rep. We need to return the letter no later than November 30th, 2020. The Council selected Charlie Moen as the rep for the City of Mayville. O'Brien made the motion to select Charlie Moen as the City's rep. Petersen seconded the motion, and the motion was carried.

Olstad brought up that the sweeper has seen its better days. The sweeper is a 1993 model. The City bought it in 2003 for \$50,000.00. It has been giving us a lot of trouble the last couple of years. The street guys figure they use it around 130 hours a year. O'Brien made the motion to find a company that would come and clean the streets one last time in 2020 before the snow flies at \$125.00/hour. Moen seconded the motion and upon a roll call vote the following voted; Yea: Petersen, O'Brien, Gates, Carr, Moen, Bohnsack; Nay: 0
